

in pursuance of the Judgement date 13,09,2013 of the Honourable Supreme Court in WP(C) No.121 of 2008—Resurgence India -vs. Election Commission of India and others, regarding the filing of incomplete affidavit of candidates, the candidates are required to fill up all columns therein. No column can be left blank. At the time of filling of affidavit, RO has to check whether all columns of the affidavit filed with the nomination paper are filled up.
